Following a conversation with Gareth Barnes on 09/04/2019 a review of the waste returns was undertaken. It has been noted that "Absorbent Hygiene Waste" coded 20 01 99 has been accepted onto site at Tondy and this waste code does not appear in the permitted wastes allowed on site.

C3 – General Management – Materials Acceptance – CAT 3 – Permit Condition: 2.2.1 (a) **Table 2.2**

You have been given a CAT 3 breach of the above permit condition because it was noted that waste coded 20 01 99 has been accepted onto site when it does not appear in the list of permitted wastes.

2.2.1 Waste shall only be accepted if: (a) it is of a type and quantity listed in table 2.2 below.

ACTION: You must cease to accept this waste at Tondy.

C1 – General Management – Staff Competency and Training – CAT 3 – Permit Condition 1.1.1(b)

You have been given a CAT 3 breach of the above permit condition because the acceptance of waste (EWC 20 01 99) onto site, which is not permitted, shows a lack of understanding of the permit and conditions within it, specifically which wastes can be brought to site.

1.1.1(b) The operator shall manage and operate the activities using sufficient competent persons and resources.

ACTION: Ensure that staff are aware of permit conditions and understand the activities which can be undertaken on site. Ensure all staff have an understanding of what the permit requires.
