Upon these visits the attending officer liaised with Keith Morris and undertook an inspection of the site to focus upon the reported issues. No dust was found to be being generated by activities at Alan's Skip Hire.

Officer was made aware that wood chipping had been occurring that morning.

The officer did not identify Alan's Skip Hire as the source of any pollutants/amenity issues.
