Permit Breaches

A routine sample collected on 27.11.2024 at 11:35 was found to contain 1870 ug/l of Aluminium. As permit **Condition 3.1.2 Schedule 3** states, the discharge shall contain no more than 1000 ug/l Aluminium, therefore a breach of your permit has occurred.
