NRW were informed by email on 13th January, 2025, that it will be necessary for Knauf Insulation to shut down the EP unit in order to complete essential preventative maintenance work. The time and date listed is between 11/02/2025 and 15/02/2025. NRW accept that this course of action is necessary.

Knauf Insulation Ltd must take all possible measures to minimise emissions during this period.

NRW must be informed of any complaints received during the shut down period and when normal EP operation is resumed.
