4. Details of our assessment

On the 23 January 2025 an unannounced site inspection was undertaken at Swansea Drydock Ltd. permit number EPR-UP3298VL. David Ellar (NRW), was accompanied

around the site by Damien Lloyd (HSEQ Manager Swansea Drydocks Ltd.).

The weather was grey and overcast and it had recently been raining.

Swansea Drydocks Ltd have a time limited permit condition which allows the site to recycle ships covered by EU Regulation 1257/2013, namely ships over 500GT, and to be included into the approved list of EU Ship Recyclers: [Annex to MGN 656 The latest UK list of approved facilities - GOV.UK](#) . This condition will cease on 2 July 2025. If you wish to continue to recycle ships to which the Ship Recycling Facilities Regulations 2015 apply, you will need to submit a variation application to NRW. If this is the case, please contact NRW to discuss the permit variation required.

Permit breaches identified:

No permit breaches were observed during this visit.

Previous inspections:

No breaches or actions were identified at our previous visit CAR_NRW0043960 on the 28 March 2024.

General Observations:

The site was generally very clean and tidy with very little waste on site. The drainage system was checked and appeared clear of debris. Some areas of the impermeable pad were damaged but appeared (storage area in between dock and operational sheds) but appeared to still be impermeable. No waste was being stored in this area during the inspection. Please ensure that if waste are to be stored in this area the impermeable pad is maintained and repaired if necessary, as per permit conditions.

Damien Lloyd (HSEQ Manager) is site TCM. Damien's continued competency expires 22/10/2026.

Waste returns:

Waste returns have been checked and were up to date. Q1, Q2 and Q3 for 2024 returns have been submitted and show a Null return.
