4. Details of our assessment

In relation to Natural Resources Wales (NRW) incident investigation WIRS 2413176, NRW identified that an scrap metal collector has been taking mixed metal waste to Phoenix

Metals and Colin Davies Non-Ferrous Metal without holding a valid waste carrier licence.

Records show that this individual has been taking mixed waste metals such as copper, end of life vehicles and alloy wheels to your site between 11th October 2023 and 18th October 2024.

W1A - General management

Permit Condition 1.1.1 - The operator shall manage and operate the activities: (a) in accordance with a written management system that identifies and minimises the risks of pollution, including those arising from operations, maintenance, accidents, incidents, non-conformances, closure and those drawn to the attention of the operator as a result of complaints.

Standard operating procedure No2 within your Environmental Management System states:

"1) Registration of Carriers Check

Unless the person/ company collecting the waste is known by the site staff to be a registered carrier of waste, or exempt from the need to register, evidence must be provided by the way of a certificate of registration or proof of exemption. If the driver fails to do so the collection must be refused."

As a result, the site did not operate the site activities in accordance with their written management system and as a result this is non-compliant with condition 1.1.1. a NRW have issued a Compliance Classification Score (CCS) 3 breach for this non-compliance.

ACTION

The site will need to improve their operations by making sure that every waste carrier bringing waste into site has a valid waste carrier licence. Moving forward you must operate in accordance with your written management system.

DEADLINE

Please operate in accordance with the procedures set out in your site EMS immediately.
