4. Details of our assessment

This compliance assessment report is being produced following an unannounced site

inspection of Rhydeion Household Waste Recycling Centre. The inspection was conducted by Luke Taylor (Waste Regulation Officer) and Chris Gilbey (Tackling Waste Crime Officer) of Natural Resources Wales. The site supervisor present was Justin Davis.

The weather at the time of the inspection was dry and bright, with no wind.

W1A - General Management

The site Environment Management System was available to officers at site, including an updated site plan which accurately depicts the location of the various waste streams. Continued Competency certificates for the two Technically Competent Managers who attend the site, Liane Timmermann and Stuart Saunders, were displayed in the office. These are both valid until 20/12/2025.

During the inspection all waste was found to be stored within the correct bays and appropriately segregated. Paint was being stored within a bund, to capture any spillage, and drums containing hazardous waste were correctly labelled.

W3B - Emissions of substances not controlled by emission limits

The site was clean and tidy, including the entrance onto the carriageway, with no evidence any waste or debris around the perimeter.
