The purpose of this Compliance Assessment Report (CAR) is to record Natural Resources Wales' (hereafter *NRW*) assessment against Continental Teves UK Limited (hereafter '*the operator*') **quarterly** [Q2, Q3 & Q4 2024] and **annual** [2024] monitoring and reporting requirements. NRW's assessment of the operator's monitoring returns data is outside the scope of this CAR and any non-compliance arising from an exceedance of a permitted emission limit will be recorded in a separate CAR.
