**Annual report**

The Annual Report submitted containing completed tables S4.2 and S4.3 satisfies Permit Condition 4.2.2 and was submitted within the required timeframe.

**Improvement conditions**

Improvement condition 17. The SF6 system has not been installed. This project has been delayed due to resource availability.

During the last site visit, the NRW officer and operator discussed future changes to the insulation. NRW suggests putting in any necessary applications as soon as possible due to longer the normal wait times for applications to be duly made.
