4. Details of our assessment

30/01/25 - Site Visit

A compliance visit for permit 21/57/24/0001 was undertaken on the 30/01/2025. A Natural Resources Wales (NRW) Environment Officer was accompanied by two Dwr Cymru Welsh Water (DCWW) Water Resources Technicians. The weather was cold, dry and sunny during the visit, with moderate rainfall in the days preceding.

There are 3 abstraction locations listed under the single permit, along with an abstraction from Llyn Fawr reservoir. All can feed the Tyn-y-Waun reservoir or be directed to feed the Llyn Fawr reservoir. The DCWW Water Resources Technician sent through all the abstraction data for the year 2024 prior to the visit. The total abstraction from all three sources was 2,194,883 cubic meters - significantly under the maximum permitted volume of 4,977,270 cubic meters. It was noted that the turbine flowmeter measuring the abstraction from the Garreg sources was faulty from the 7th of December 2024 until the 6th of January 2025. For this period, the total volume passing through the Tynywaun WTW was used (subtracting the volume recorded by the Ffermol and Selsig flows). Meter calibration happens annually via an external contractor.

During the visit, it was noted that the Garreg Llwyd intake was operating as designed. There were no obstructions or build ups on the intake or compensation notch. Approximately 100m upstream from the intake appears to be some staining from a mine water discharge, although this didn't look as prevalent as in previous visits. The intake chamber was lifted, and there was no build up of debris to be seen. Maintenance visits are carried out every 4-6 weeks to identify issues. The intake overflow was working as intended, sending excess water downstream.



The Intake at the Nant Carnfeosen and Nant Melyn was also clear, with water passing over both the intake and the compensation notch.



No breaches of permit, nor actions to be completed.
