Jonathan met me on site at the farm, he showed me the dipping bath which was made of concrete flooring and breeze block walls with large collection / holding pen (40 sheep).

The yard area next to the dipping bath was also concrete and then leads to a small field where they would stay over night, not near any water course.

Spreading locations - SJ0277059220 SO0270059950- dates from 1 April to 31st March

permit - Max Volume sheep dip working strength - max 4 cubic meters per annum

Daily rate - as above 1 cubic meters on an area of 0.2 Hectares - further diluted 1 part dip to 3 parts slurry shall not exceed 4 cubic meters over 0.2 Hectares.

Records kept in a diary and purchased medicines kept in Medicine book.
