4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards of Natural Resources Wales, accompanied on site by employee of Pic Up Spares.

General Management - W1A.

The permit and current Environmental Management System (EMS) were provided on request to officer.

Site diary was reviewed during the inspection, completed daily and showed records demonstrating maintenance of interceptor and drainage system as required under **condition 6.2.1.**

Action - Please provide confirmation of the technically competent manager (TCM) certification.

Waste Operations - W2

End of life vehicles were stored on an impermeable surface at the rear of the site, with the benefit of sealed drainage system to collect any liquids as required under **condition 1.2.1.** Granules were noted to be available for the clean up of any oil spills from the activity as required under **condition 5.1.3.**

The depollution process was undertaken within the building, with waste liquids stored within double bunded tanks on impermeable surface in line with **condition 1.2.2 and 3.2.1 referring to Table 3.1.**

Action - During the inspection it was noted that a refrigerator from the site was stored with some scrap metal wastes, as discussed, ensure that wastes from the office/buildings are not stored with waste produced from the permitted operation and removed to suitably authorised facilities as required.

Waste identified during the inspection were compliant with the conditions of the permit and stored within the permitted boundary.

Emissions - W3D

Noise from on site operations during the inspection were not at levels likely to cause pollution to the local area.
