4. Details of our assessment

30/01/25 - Site Visit

A compliance visit for permit 21/57/24/0007 was undertaken on the 30/01/2025. A Natural Resources Wales (NRW) Environment Officer was accompanied by two Dwr Cymru Welsh Water (DCWW) Water Resources Technicians. The weather was cold, dry and sunny during the visit, with moderate rainfall in the days preceding. There had been multiple heavy rainfall / storm events earlier in the winter.

There is a single abstraction location listed under this permit. The DCWW Water Resources Technician sent through all the abstraction data for the year 2024 prior to the visit. The site is permitted for 1,400,463 cubic meters of abstraction annually. The data shows a total abstraction of just 12,996 cubic meters in 2024, well below the permitted limit.

The intake itself was clear from obstructions, and there was water flowing through the compensation notch. As can be seen in the photo below, the compensation notch was partially obstructed by rocks which had been washed downstream in the recent heavy rainfall events. This would be restricting flow over the compensation notch, which could have a detrimental impact downstream during low flows, and will need to be cleared. The DCWW Water Resources Technician explained that due to the topography upstream of this intake, it regularly requires boulder removal after heavy rainfall events.

**Actions:**

- Clear the compensation notch of obstructions.
