4. Details of our assessment

Compliance Assessment Report (CAR) for the review of the 2024 Annual Report and the Annual monitoring returns submitted to Natural Resources Wales (NRW) for permit BX4666IZ.

Annual report

The Annual Report submitted containing completed reporting forms covering tables S4.1 and S4.2 satisfies Permit Condition 4.1.3 and was submitted within the required timeframe.

Permit condition 4.1.2 was also satisfied by the operator submitting a Solvent Report.

Annual monitoring

Monitoring returns were submitted within the required timeframe, required by Permit Condition 4.1.2. All monitoring required by Permit Condition 2.10 was completed. All reported parameters were compliant with specified emission limits levels.

During a review of the operators 2023 annual monitoring (CAR_NRW0043405), it was identified that they were close to their emission limits on emission point A5.

To address this, the operator has replaced the equipment associated with A5, resulting in, the emission point becoming redundant with no equipment connected to it therefore no monitoring was submitted for point A5, this was agreed with NRW.
