4. Details of our assessment

Introduction

This Compliance Assessment Report is a review of the Q4 and annual returns for Margam Green Energy Ltd.

Q4 October to December 2024

The Q4 submission included all the results for quarterly parameters required over this period.

The reported emissions were within the emission limits specified in the permit for the monitoring period, with the exception of two Schedule 5 reports for exceedance of emission limits.

A Schedule 5 notification submitted to NRW on 9 October 2024 gives a half-hourly CO result for 8 October at A1 as 173 mg/Nm³ against the permit limit of 150 mg/Nm³.

The Part B notification explains the adjustments made to plant settings during the commissioning of boiler cleaning equipment caused a brief spike in CO. This was immediately rectified by the operator.

A Schedule 5 notification submitted to NRW on 21 October 2024 gives a half-hourly CO result for 20 October at A1 as 247.5 mg/Nm³ against the permit limit of 150 mg/Nm³.

In this instance, the operator reported that the cause of the breach was deposits of boiler fouling affecting the combustion waste layer thickness. This affected air flow, causing a spike in CO. Since the incident, additional boiler cleaning has been added to prevent boiler fouling.

Compliance: The above results are in exceedance of the emission limits set in the permit for A1 and in breach of condition 3.1.2. Non-compliance categories of C3 against criteria IR3A (2) Emissions to air has been allocated to these breaches for the Q4 reporting period.

We have consolidated the non-compliances for CO emission limit breaches into one for the Q4 reporting period.
