**4. Details of our assessment**

This Compliance Assessment Report (CAR) has been issued in response to the submission of the Q4 (October - December) 2024 monitoring returns by RWE Generation UK plc (the operator) for activities at Pembroke Power Station, West Pennar, Pembroke, Pembrokeshire, SA71 5SS under permit EPR-DP3333TA.

This CAR was undertaken on 4 February 2025. However, to ensure that the CCS score is attributed to the correct financial year (for billing) the date on CARS has been altered to 31 December 2024.

**Q4 2024 Monitoring Returns****Releases to water** - *Water 1 (10/11/11)*

The returns for reporting of sampling and analysis of emissions to water (other than sewer) to emission points W1, W1 (a), W1 (b), W1 (c), and W2 for Q4 (1 October - 31 December) 2024 were submitted by the operator to NRW on 20 January 2025.

**Releases to air** - *IED/LCPBREF CON2 (Gas turbines) and IED/LCPBREF PM1*

The monitoring return results were submitted by the operator to NRW on 20 January 2025 for LCP286 (Unit 11), LCP382 (Unit 21), LCP383 (Unit 31), LCP384 (Unit 41), and LCP385 (Unit 51).

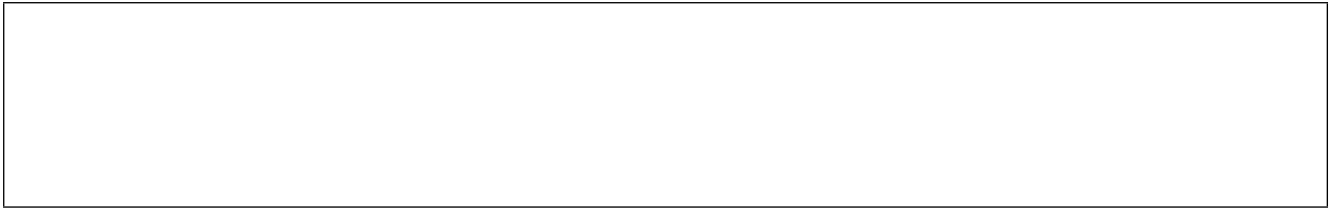
- The data was sent within the Q4 reporting period, which is **compliant** with permit condition 4.2.3.
- The monitoring was undertaken within the Q4 monitoring period, which is **compliant** with permit condition 3.5.1.
- Based on the reports submitted by the operator, emissions at the monitoring points for Nitrous Oxide (NO<sub>x</sub>), Sulphur Dioxide (SO<sub>2</sub>), and Carbon Monoxide (CO) appear **compliant** with the site's specified emission limits over the Q4 reporting period.
- Based on the reports submitted by the operator, all other emissions at the monitoring points appear **compliant** with the specified emission limits over the Q4 reporting period.
