4. Details of our assessment

This was a routine review of data carried out by Malcolm Dines (Waste Regulation Officer) to assess compliance with the Agricultural Benefit Statement of the deployment. Spreading records were requested for 2024 and reviewed with regards the overall spreading rate and the spreading rate for each field and that waste had been spread on land that is authorised by the deployment.

All spreading complied with the approved Agricultural Benefit Statement

Permit Breaches

W4C - Notification - Permit condition 4.3.4 - Cat 3

You have received the above category 3 breach of permit condition 4.3.4 because the spreading records you submitted for 2024 show that we did not receive a prenotification for the spreading you carried out on 10 and from 31 July until 14 August 2024.

Because the conditions of your permit are written to be environmentally protective, it is therefore reasonably foreseeable that the failure to comply with a permit condition could result in minor harm to the environment and so the breach receives the above score.

Prenotification is one of the ways that allows me to review your compliance with your Agricultural Benefit Statement and for this deployment your Agricultural Benefit Statement set out that wastes would be spread in spring and early summer and I would question whether the second week in August is really "early summer".

Action: ensure that you submit prenotifications as required by permit condition 4.3.4 and that you comply with all aspects of your Agricultural Benefit Statement **with immediate effect**
