4. Details of our assessment

This Compliance Assessment Report (CAR) has been issued in response to the submission of the annual monitoring returns 2024 (1 January - 31 December) by Materials Recovery and Energy Centre for activities by Neath Port Talbot Country Borough Council (*the operator*) at Crymlyn Burrows, Swansea, SA1 8PZ under permit EPR-BJ5775IF.

This assessment was undertaken on 5 February 2025. However, to ensure that the CCS score is attributed to the correct financial year (for billing) the date on CARS has been altered to 31 December 2024.

Annual Monitoring Returns 2024

Permit condition 4.2.3 requires the operator to conduct:

- 4.2.3 For the following activities referenced in schedule 1, table S1.1: AR1, a report or reports on the performance of the activities over the previous year shall be submitted to the Environment Agency by 31 January (or other date agreed in writing by the Environment Agency) each year. The report(s) shall include as a minimum:
- (a) a review of the results of the monitoring and assessment carried out in accordance with the permit including an interpretive review of that data;
 - (b) the annual production / treatment data set out in schedule 4 table S4.2; and
 - (c) the performance parameters set out in schedule 4 table S4.3 using the forms specified in table S4.4 of that schedule.

Following the decommissioning of the Waste to Energy Plant in 2013, emission points A2, A4, and A5 are not connected to any plant equipment. Subsequently, all emissions to air have been submitted with a NIL result.

- The annual monitoring returns for 2024 were submitted on 20 January 2025. This data was

sent within the reporting period, which is **compliant** with permit condition 4.2.3.

- The monitoring return submissions for Q1, Q2, Q3, and Q4 in 2024 were made inside their respective reporting windows, which is **compliant** with permit condition 4.2.4.
- The monitoring returns submitted include reporting of monitoring carried out in respect of the parameters and emission points specified in schedule 4 table S4.1, S4.2, and S4.3 which is **compliant** with the environmental permit.
- The monitoring returns submitted are for the reporting periods specified in table S4.1 and S4.2, which is **compliant** with the environmental permit.
- The monitoring returns have been submitted using the forms specified in table S4.4, which is **compliant** with the environmental permit.
- The monitoring returns submitted include results and assessments as required by the forms specified in table S4.4, which is **compliant** with the environmental permit.

Based on the reports submitted by the operator, all emissions at the monitoring points and permitted parameters appear **compliant** with the specified emission limits for 2024.
