## 4. Details of our assessment

### Forward Waste Management Limited

This compliance assessment report (CAR) details the following:

- Quarter four (October – December) 2024 waste returns.
- Review of the annual performance parameters for 2024 as required by permit condition 4.2.2

### Quarter four waste returns 2024

The waste returns for quarter four were received within the reporting window. A total of 282.8 tonnes of waste was received and a total of 258.9 tonnes removed during this period. All received EWC codes were compliant with the permit.

### Annual Returns

\*Please note – the annual reporting forms have been submitted with the incorrect permit reference number contained on the heading. It appears this mistake was present when the form were issued to Forward waste when the permit was issued.

A total of 823 tonnes of waste was processed through the installation during 2024, well within permitted limits.

Water usage – A total of 134m<sup>3</sup> of water was used by the installation, this equated to a specific usage of 0.163m<sup>3</sup> per tonne of waste processed through site.

Energy use - A total of 73.01 MWh of primary energy was used by the installation (30.422 MWh delivered electricity with conversion factor of 2.4). This equated to a specific usage of 0.089 MWh per tonne of waste processed.

No raw materials reported to be used at the installation.

As the installation is primarily a transfer station with no treatment operations being conducted, the use of electricity and water is primarily for 'domestic' purposes.
