Continuous pH monitoring was reported to be within limits for July. The site was vacant following this, NRW agreed to allow Biffa to remove the pH probe following removal of all inventory from site.

Annual performance

A total of 933.09 Tonnes of hazardous waste accepted onto site, with 0 tonnes treated. A total of 302.69 Tonnes of non-hazardous waste was accepted on to site.

Q4 waste returns

A null waste return was received and is accepted.

The site has been vacated, with all inventory removed and operations re-located to the newly permitted installation at Lamby Way. A permit surrender application has been submitted.
