### 4. Details of our assessment

The Annual Report submitted satisfies Permit Condition 4.2.2 and was submitted within the required timeframe. The report also covers areas of energy efficiency, use of raw materials and waste minimisation. These areas address Permit Conditions 1.2.1, 1.3.1 and 1.4.2 at an annual frequency which, is over and above that required by the four year frequency defined by the permit conditions.

The operator was unable to fulfil Permit condition 4.2.3. As stated in their annual report '*The site stopped using the older nitric acid tank and the associated scrubber unit in May 2024. No further products containing Nitric acid were manufactured therefore no environmental emission monitoring was able to be conducted in 2024*'.

NRW was informed in May that no more orders using the nitric acid would be produced until, the new nitric acid tank came into use in October 2024. Therefore they would be delaying their emission monitoring until then.

The commissioning of the new tank was delayed until 2025, NRW were informed of this and it was agreed no emission monitoring would take place in 2024.
