4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by the Natural Resources Wales (NRW) regulating officer to comment on the 2024 Annual Report.

The annual report was submitted on 23/01/2025 in accordance with Condition 4.2.1 of the Permit.

Performance Indicators have been recorded for the period 01/01/2024 to 31/12/2024 and are as follows:

- Production Man Hours decreased by approximately 8.57% on 2023 (77,587 hours) to 70,936 hours.
- Electricity usage is 1,960,339Kwh, which is lower than 2023 usage (2,025,110 per Kwh), and reflects the decrease in production man hours.
- Gas usage in 2024 was 50,165m³ compared to 67,652m³ used in 2023. This equates to approximately a 26% reduction in gas usage on 2023.
- 408 tonnes of waste was produced, which equates to 0.0057 tonnes per production man hour, this is a slight decrease on 2023. Specific waste streams are captured by specific allocated bins which were introduced in line with April 6th 2024 Workplace Recycling Regulations.
- Water usage for 2024, is recorded as 783m³, (0.01103m³ per production man hour) and is lower than waster usage for 2023 (1,221m³, which was 0.015m³ per production man hour).
- There has been no contamination or decontamination of the site in the year.
