4. Details of our assessment

An announced site inspection was undertaken at Sherwin Williams Ltd, Deeside Packaging Coatings, Parkway, Deeside Industrial Park, Deeside, Flintshire, CH5 2NN at 10:30 am on the 6th February 2025 by NRW officers Phil Harper and Carter Shone, Senior Industry and Waste Regulation.

The plant was operational at the time of inspection.

(IR1A) General Management

Observations made during the visit will be discussed below.

Internal Manufacturing and Storage Areas

Internal manufacturing and storage were being maintained to a high standard of cleanliness.

Outdoor Storage areas including tank farm.

Tank farm bunds were visually in a good condition and any rain water had been removed. Site drains were visually clear from obstruction.

Abatement

A walkthrough of site abatement systems was provided during the inspection. Abatement Systems appeared to be operational and in good condition. Site operatives discussed how internal and external monitoring data was being used to ensure that abatement was working optimally at the site.

No breaches of permit were identified during the inspection.
