4. Details of our assessment

A routine site inspection was undertaken on Friday 31st January 2025. The previous inspection of the site by Natural Resources Wales was on 15th June 2023.

Operational Status

At the time of the inspection, on Friday 31st January, it was noted that operations on site had ceased.

All waste, processing plant and equipment had been removed from site.

On receipt of this Compliance Assessment Report, please confirm the intentions of Celsa Manufacturing (UK) Ltd going forward.

A brief inspection of the site was undertaken. It was noted that there were several areas where the impermeable site surface was damaged, water had pooled and underneath was unmade ground. At the time of the inspection, however, operations did not appear to have had a lasting impact on site.

There were no visible signs of a significant impact/pollution left on site. The site, although accessible at the time (due to staff on site removing plant/equipment) is considered secure. It is noted that the docks area in general benefits from 24-hour security.

Permit Surrender

As operations at site have now ceased, you may wish to consider surrendering the Environmental Permit at site.
