4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised in relation to the annual monitoring and reporting requirements of the permit.

The annual reporting for 2024 was received on 28th January 2024 in compliance with permit condition 4.2.2. Emissions to air for A1, A2 and A5 emission points have been monitored as per permit condition 3.5.1 and reported as per permit condition 4.2.3. Schedule 4(b) Table S4.1.

The reported emissions from A1 and A5 emission points were in compliance with the emission limit values (ELV's) detailed in Schedule 3(b) Table S3.1.

The flare stack, emission point A2 only operated for 2.47% of the time.

An Annual Environmental Report was submitted on 28th January 2025 which satisfies permit condition 4.2.2(a).

Performance data was submitted as per Schedule 4 Table S4.2 and Table S4.3 in compliance with permit condition 4.2.2.

Q4 2024 Waste Returns

The Q4 2024 waste returns were submitted in accordance with permit condition 4.2.5. The waste returns were reviewed and all waste accepted was in compliance with Permit Condition 2.3.2, schedule 2, table S2.1. The total waste accepted for 2024 was 20,067.6 tonnes which is within the permitted limit of 26,500 tonnes.
