4. Details of our assessment

This Compliance Assessment Report follows the review of annual returns and monitoring data for 2024.

Annual Emissions Monitoring Air (Form Air1)

The data for the annual monitoring was submitted on 10th February 2025 for emission points A1, A2 and A10 as required by Permit Condition 4.2.3, Schedule 4, Table S4.1. No units of measurements were included in the data.

There are no permitted Emission Limit Values (ELVs) for these emission points.

Annual Emissions Monitoring Water (Form Sewer1)

The data was submitted on 10th February 2025 for emission point S1 as required by Permit Condition 4.2.3, Schedule 4, Table S4.1. No units of measurements were included in the data.

There are no permitted ELVs for these emission points.

Annual Report

The annual report was submitted on 10th February 2025 as required by Permit Condition 4.2.2.

Nitrogen Oxide emissions have decreased on all 3 emission points compared to 2023 data.

There was a slight increase in production volume since 2022.

With reference to water emission point S1 there have been further reductions in Chemical Oxygen Demand (COD) and suspended solids in this discharge and the flow has also reduced from 2023.

There was only a slight increase in water usage in 2023 compared to 2022 but the site has

continued to improve efficiencies in energy usage and waste generated compared to 2023.

Although all the data that is required by the permit was supplied there was no interpretative review of the data provided as required in Permit Condition 4.2.2 (a).

Due to the late submission of the annual reporting, not providing an interpretative review of the data and omission of units of measurement a score has been applied;
