4. Details of our assessment

Compliance Assessment Report (CAR) for the review of the 2024 Annual Report submitted to Natural Resources Wales (NRW) for permit WP3938SH and annual monitoring returns.

Annual report

The Annual Report submitted containing completed reporting forms covering tables S4.2 and S4.3 satisfies Permit Condition 4.2.2 and was submitted within the required timeframe.

Annual Monitoring

Monitoring returns were received on 31/12/24, within the timeframe required by Permit Condition 4.2.3. All monitoring required by Permit Condition 3.5.1 was conducted and all reported parameters were compliant with specified emission limits levels.

The monitoring did not take place during the specified reporting period as required by permit condition 4.2.3 (a). The operator informed NRW, on the 27th Dec 2024, that it was unable to book a MCERTS accredited contractor during November or December 2024 to carry out the monitoring. Therefore, they scheduled emissions monitoring between 14th and 17th January 2025.

NRW advises the operator that the annual monitoring can take place during any time within the year long reporting period. For example other operators do their monitoring earlier in the year to avoid scheduling issues such as this.

This has resulted in the following score:

(IR3E) Monitoring. Permit Condition 4.2.1(a). Compliance Score C4.

Action: Ensure emissions monitoring takes place within the required time frame.

Please note that the monitoring that took place between 14th and 17th January 2025 can not be submitted for the 2025 reporting period.
