4. Details of our assessment

This CAR form has been raised for the submission of Q1-Q4 2023 waste data. Waste returns have been submitted for all quarters in 2024 as required by Permit Condition 4.2.5. The site is post operational and no emissions monitoring have been reported for 2024.

The waste returns for 2024 were all null returns.

The following actions are still outstanding from the previous CAR form NRW0045134:

1. Confirm if the intention is to surrender the permit and what plans with timelines are in place for this
2. Provide evidence of waste characterisation and assessment plus copies of consignment notes for the removal of waste fines located in the building
3. Confirm if the waste stones and rubble have been tested to check there is no contamination from previous activities and what the plan is for this material
4. Provide a definitive date when the surface water lagoon will be emptied

The deadline date for all of these actions was 31/10/24.

As no responses have been received for these a score has been applied against permit condition 1.1 General Management;

Action

Provide an update on the outstanding actions from CAR form NRW0045134 by 28th February 2025

Despite repeated requests to update NRW on the permit surrender process no updates or communications have been received from the site.

It is advised the application for permit surrender is completed and submitted as soon as possible as the site has been decommissioned and in the process of being dismantled and demolished. Any environmental impacts of these demolition activities needs to be considered.
