This Compliance Assessment Report (CAR) has been generated by the Natural Resources Wales (NRW) regulating officer to comment on the 2024 Annual Report.

Annual performance reporting Condition 4.2.2 of the permit requires:

A report or reports on the performance of the activities over the previous year shall be submitted to the Agency by the 31st January (or other date agreed in writing by the Agency) each year.

The report(s) shall include as a minimum: (a) a review of the actual and potential operations of the installation against the low impact criteria issued by the Agency at the time of the review; (b) where the operators management system encompasses annual improvement targets, a summary report of the previous years progress against such targets; and (c) details of any contamination or decontamination of the site which has occurred.

The annual performance report was received on the 23 January 2025 and provided the specified information as required by the permit.

The site is therefore compliant with this requirement.

### Actions

A number of Actions were raised in the previous CAR (Ref CAR\_NRW0045239). Further information is required close out the actions, as follows:

- *Relocate the hose drip trays to within the bund and provide confirmation to NRW by 31 October 2024 (Action 1).*

A management of change form was provided 15 October 2024, which outlined a programme for completing the action. **Please provide NRW with confirmation that the action has been completed by 31 March 2025.**

- *Investigate a means of protecting the permeable ground adjacent to the warehouse entrance in the event of a tank failure and report to NRW by 30 November 2024. (Action 2)*

A management of change form was provided 15 October 2024, which outlined a programme for completing the action. **Please provide NRW with confirmation that the action has been completed by 31 March 2025.**

- *Provide confirmation to NRW that the upgrade to the HCL bund has commenced and include the planned programme of works to completion by 30 November 2024 (Action 3)*
