4. Details of our assessment

A routine compliance inspection of Padeswood Cement Works was undertaken on the 14th January 2025 during the annual shutdown. The annual shutdown work includes the replacement of refractory material in both the kiln and pre-heater tower vessels. Work is planned to minimise disruption to the public and mitigation measures are in place to minimise nuisance noise. The inspection was specifically to review the kiln wrecking activities. The Sustainability Analyst and Assistant Production Manager accompanied the visit.

The brokk was not in use at the time of arrival, however, this activity started during the visit. I specifically wanted to assess the noise from the brokk to understand its impact on residents. The noise from the brokk is considerable and its intermittent nature would be disturbing to residents, however, the operation of the brokk is limited to 7am to 10pm. There was various signage in place informing operatives and contractors of this restriction. Correspondence had been sent to members of the local liaison committee and immediate neighbours prior to the shutdown warning them of the activities.

A disab was onsite during the visit at the rear of the raw mill building and was creating a low drone. This activity had ceased by the end of the visit.

Further loud banging was heard around the site during the visit relating to other maintenance activities. There were numerous contractors on site undertaking the various required maintenance activities.

On the 31st January 2025 officers undertook a further site inspection. Bricking of the kiln was ongoing at the time and officers spent time observing this activity.

The eco barrier sounds blankets used during the shutdown works were viewed. These had been trialled at night whilst disabs were operational. Noise monitoring was undertaken offsite at the time. It was deemed that the noise was not reduced enough by these blankets and the activity was halted. The Operator stated that they are going to continue to trial the use of the eco barrier sounds blankets during certain operations and continue to monitor their effectiveness.

Shift Managers have proactively been out in the local area at various times during the night undertaking noise measurements to monitor the impact of any overnight maintenance activities.

The Operator stated that they were likely to commence start up and be back to normal operation week commencing 10th February 2025.
