Permit Breaches

Review of regulatory monitoring results carried out by Ceri Malone, Environment Officer of the Cwm Taf and Bridgend Environment Team.

On 31/01/2025 the team was made aware of a regulatory monitoring water quality sample failure from Tower Colliery. The water sample was taken on 23/01/2025 at 12:51 from the sampling point specified on permit number AN0314801 (NGR SN 94809 05440). The water quality sample was tested and showed 298mg/l of suspended solids. Your limit is 80mg/l (measured after drying at 105°C).

Actions

- Please investigate and explain why this exceedance has taken place and explain what measures are being put in place to prevent future exceedances.
- Provide records of site monitoring carried out around that date which may have identified issues.
- Provide an update to actions 2-4 in the email dated 11/12/2024 - the purchase a new turbidity meter, weekly total suspended solids laboratory testing and adjustment of on-site results.
