4. Details of our assessment

On the 29/1/2025 NRW and HD attended the Arddleen and Buredin sewage works to undertake a site visit. The purpose of the visit was to do a visual inspection of the final effluent and sampling chamber to ensure compliance with sections of the discharge permit.

Sample chamber and reedbed show recent signs of storm flooding. This is known to be an issue on

the site and future investment is in place to mitigate against future flooding.

The current mess caused by the flooding is localised to the site and does not impact on the quality of the discharge. Contractors are scheduled to attend once the current storms have passed.

No issues on site to address other than localised flooding and this is addressed through AMP 8.
