4. Details of our assessment

On the 29/1/2025 NRW and HD attended the Llanfair Caereinion Sewage works to undertake a site visit. The purpose of the visit was to do a visual inspection of the final effluent and sampling chamber to ensure compliance with sections of the discharge permit.

Due access to both the CSO chamber and the outfall being limited the inspection was limited.

Review of the permit identifies condition 2.4.1 improvement program requiring HD to give information on any screening with in 2 years of the permit issue, I am not able to find a record of that.
