4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by Natural Resources Wales (NRW) regulating officer to comment upon the annual monitoring data and annual report for the regulated facility.

Annual Monitoring Data

Air Emissions - Emission Point A2

Annual air monitoring was undertaken on the 5 April 2024 and submitted to NRW on 31 January 2025 in accordance with Condition 4.2.3.

Air emissions monitored for particulate matter (PM), lead (Pb) and volatile organic compounds (VOCs) were reviewed and all emissions were reported to be below permitted ELVs.

Emissions to Sewer - Monitoring Point S1

Annual sewer sampling and monitoring was undertaken on 29 January 2024, 7 March 2024 and 7 June 2024 and submitted to NRW on 31 January 2025 in accordance with Condition 4.2.3.

Sewer discharges analysed for Pb and chemical oxygen demand (COD) were reviewed and all emissions were reported to be below permitted ELVs.

Annual Report

Energy (E1) and waste data (R1) submitted for 2022 for permitted installation on 31 January 2025 in accordance with Condition 4.2.3.

Energy Usage - E1

Electricity usage has steadily reduced since the 2021 reporting period and is attributed to lower production volumes. Carbon dioxide (CO₂) emissions have decreased from 2023.

Waste Data - R1

Reported waste data figures record a significant increase in volumes of cable scrap and waste PF4 and oils. Reported figures do not indicate any significant changes to other waste streams amounts based on previous years data.

Environment Management System

During May 2024, a third-party audit body, RINA undertook a surveillance audit to ISO 14001:2015 Environmental Management System and ISO 45001:2018 OHSMS. Both certificates were retained.

Actions

A number of actions were identified in the previous CAR (ref: CAR_NRW0044620), issued 29 July 2024.

The actions were principally associated with the provision and implementation of environmental procedures associated with, roles and responsibilities, scheduling of monitoring and testing, preventative maintenance, and incident management.

The Operator provided a package of documentation in response to the actions in an email dated 11 September 2024. A preliminary review of the information has been undertaken by the NRW officer and will be considered in more detail at the next site inspection.
