Compliance Assessment Report (CAR) for the review of the 2023 Annual Report and the Annual monitoring returns submitted to Natural Resources Wales (NRW) for permit BB3397HN.

Annual report

The Annual Report submitted containing completed reporting forms covering tables S4.2 and S4.3 satisfies Permit Condition 4.2.2 (a)/(b). The operator submitted the report on the 4th Feb 2025 after being prompted by NRW. This is outside of the timeframe stated in permit condition 4.2.2.

This has resulted in the following score;

(IR3E) Reporting. Permit Condition 4.2.2. Compliance Score C4.

Annual monitoring

Monitoring returns were received but, the operator is not using the solvent tank relating to the emission point and therefore there are no results for 2024. Therefore monitoring required by Permit Condition 3.5.1 was not conducted
