4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised following a review of the annual air monitoring and annual reporting requirements.

Annual Monitoring

The annual monitoring reports were received on 30th January 2024 for discharges from emission points A1, A2 and A3 in compliance with permit condition 4.2.3. All reported parameters were in compliance with the Emission Limit Values (ELV's) detailed in Permit Condition 3.3.1, Schedule 3(b), Table S3.1.

The testing report for emission point A4, boiler emission exhaust was also provided although no ELV's have been set for this emission point.

Annual Reports

The annual report was received on 30th January 2024 in compliance with permit condition 4.2.2, Schedule 4, Table S4.2 and Table S4.3.

Electricity energy efficiency (MWh/t) has improved since the CHP unit has been installed compared to 2023 but gas usage has increased. There was an increase in water usage which is linked to the increase in production volumes but overall water efficiency has been maintained compared to 2023.

A permit variation has still not been applied for to include the CHP unit with extra emission point and this was not included in the recent round of air monitoring.

A permit variation needs to be applied for as the CHP unit is a directly associated activity and needs to be included in the permit.
