**4. Details of our assessment**

This Compliance Assessment Report (CAR) has been raised following a review of the annual reporting requirements and 6 monthly monitoring of air emissions.

The annual and 6 monthly reports were submitted on 30<sup>th</sup> January 2025 in compliance with permit condition 4.2.2 and 4.2.3.

Air emissions monitoring was undertaken on A1 emission point on 18<sup>th</sup> November 2024 and the results were all in compliance with the emission limit values (ELV's) applied by permit condition 3.5.1 Schedule 3 Table S3.1.

No leachate was discharged from emission point S1 as all the waste water is removed by tanker for off-site disposal.

The bio-aerosol monitoring was undertaken on 26<sup>th</sup> November 2024 and all the results were in compliance with the ELV's applied by permit condition 3.5.1 Schedule 3 Table S3.4.

As per permit condition 3.5.1 Schedule 3, Table S3.3 a report must be submitted annually detailing the efficiency and effectiveness of the bio filter. This was completed on 18<sup>th</sup> November 2024 and the reported efficiency was 97.2%.

**Waste returns**

Condition 4.2.2 requires that waste returns for the previous quarter shall be submitted within one month of the end of the quarter. Waste returns were submitted for all quarters in 2024. Waste returns have been reviewed and no issues found. The quantity of waste accepted for 2024 was well below the permitted limit.
