4. Details of our assessment

I attended site on the 23d January 2025 on a routine OSM inspection. The weather was cold and showery. I was met by the Site Operator, Senior Operator for the area and Process Scientist – thank you for your time during the inspection.

The primary tank showed some signs of aging, and the filter media had some slight ragging in places with uneven distribution due to the nature of the site. We discussed the issues with the site and the improvement condition in place due to be completed by April 2028. The discharge at the time of the inspection appeared clear. We did not inspect the outfall due to the complications of the site belowground, the exact outfall is

uncertain but a significant distance away and likely below water level at time of inspection. This site changed in 2024 from a numeric to a descriptive permit as such it has no ongoing monitoring requirements for NRW compliance.
