4. Details of our assessment

I attended site on the 23d January 2025 on a routine OSM inspection. The weather was cold and showery. I was met by the Site Operator, Senior Operator for the area and Process Scientist – thank you for your time during the inspection.

We started at the inlet and progressed through the treatment process for the site. There was no indication of excessive carryover in the primary settlement but it did appear to have been affected by the recent heavy rainfall. There was discussion on site about the potential for amending the current setup (3 chambers) in the future to improve settlement and operational capacity in the future. The flow on the filterbed appeared to be well distributed although there was an operative on site repairing an issue prior to and during our inspection. The final settlement tank appeared to be operating as expected. There was a build up around the outfall with sewage fungus evident – though it was unclear on the exact nature of the build up.

ACTION: Maintain the outfall to ensure it remains clear and free flowing.
