4. Details of our assessment

This Compliance Assessment Report is being produced following an unannounced visit to Cilmaenllwyd Household Waste Recycling Centre. The inspection was conducted by Luke Taylor (Waste Regulation Officer) and Chris Gilbey (Tackling Waste Crime Officer) of Natural Resources Wales.

The weather at the time of the inspection was dry and bright, with no wind. The officers were accompanied by the site supervisor, Aled Jones.

W1A - General Management - Permit Condition 1.1.1 - ACTION ONLY

The site Environment Management System was available to review, including a site plan which accurately reflected the location of the various waste streams. The Continued Competency certificate for the site's Technically Competent Manager, Lindley EVANS was held, with an expiry date of 23/02/2025.

The metal skips being used to store waste televisions and monitors were full above the top, with one propped up against the rear most skip. Your permit states that waste shall only be stored within designated skips, drums and tanks upon an impermeable pavement. Mr Jones explained that new skips had been requested and were due imminently.

ACTION - Ensure that the skips are emptied/replaced so that waste is not being stored on the impermeable surface. Deadline - 31/01/2025

The site was clean and tidy, with no evidence of pollution visible. The area outside the site and the access road was free from any waste or debris.
