3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

This compliance form is a result of a spill at Ystrad Owen SPS on the 20th of October 2024. This spill lasted until the 28th of October 2024.

The cause of the spill was due to pump 1 failing, and an electrical fault in the changeover panel which resulted in pump 2 not starting up. The pump failure alarm was text to the operations crew on the 20th of October but was cleared automatically without any site attendance and did not alarm again.

DCWW did not attend site until the 28th of October where the asset was noticed to be spilling on the Storm Overflow Map where the changeover panel was reset. Telemetry highlights a spill from site from the 20th-28th October.

Supervisor and pollution technician visited site on the 1st of November and located the EO within the wet well and the outfall at the brook. The outfall is located within a small brook currently with no flow. The brook looked to be able to lead into a small stream adjacent to this via a concrete channel when flows are higher.

DCWW took samples from small puddles within the brook which showed minimal impact, however, this is not representative as the spill had stopped a few days prior.

With the cause of this spill being due to electrical failure that is not a third party, NRW have determined that this spill is non-compliant with this site's permit under the following condition:

2.3 Operating techniques -

2.3.2 - For the discharge specified in table S3.3:

(a) The discharge shall only occur when and only for as long as either:

(i) the flow passed forward is equal to or greater than the overflow setting indicated due to rainfall and/or snow melt or

(ii) the hydraulic capacity of the sewer network downstream of the combined sewer overflow is reached due to rainfall and/or snow melt and the level of storm sewage in the sewer at the combined sewer overflow is greater than the weir level of the overflow structure which is specified as an overflow setting in table S3.3.
