4. Details of our assessment

Resources Management UK Ltd (RML), operates Withyhedge Landfill under the provisions of an EPR Permit (MP3330WP).

The Site is a non-hazardous landfill and was constructed in two phases. Phase 1 accepted waste from 1985 until its closure in 2006. Phase 2 is where the current active tipping area is found at the Site.

Purpose of Compliance Assessment

The following monitoring returns and reports have been assessed within this Compliance Assessment Report (CAR):

- Quarter 3 (Q3) July to September 2024 Monitoring Returns

Compliance Assessment

Q3 2024 Monitoring Returns

The operator submitted the Q3 2024 monitoring returns on 28th October 2024, which is within the specified reporting period stated in the EPR permit (Permit Condition 4.2.3).

Groundwater Monitoring

During the Q3 2024 reporting period, the required groundwater monitoring has been undertaken in compliance with EPR Permit.

No breaches of the trigger levels have been recorded. No exceedances of the current groundwater control levels were noted throughout the monitoring period.

Surface Water Monitoring

The required surface water monitoring for the quarter was undertaken and the relevant data submitted.

The results from the samples recovered at emission point D1 were within the permitted limits.

Landfill Gas Monitoring

Monitoring of the perimeter boreholes was undertaken to the frequency required by the permit (monthly). No exceedances of the emission limits listed within the permit were recorded.

Monitoring of the combustion engines (NO_x and CO) was undertaken during the monitoring period, in accordance with table S4.2 of the EPR Permit. Monitoring results are in compliance with emission limit values.

Leachate Monitoring

A total of 5029.72 Tonnes of leachate was removed off-site during Q3 2024.

Leachate levels were compliant throughout the monitoring period; with no exceedances of the limit (1m above cell basal liner) noted.

The total leachate volume extracted from boreholes LE1 – LE6 (Phase 1) was lower than the minimal monthly limit of 106 m³/month. While the low leachate extraction reflects the levels of leachate in the wells, the site is potentially in breach of permit condition 2.8.1.

Note: The operator has submitted a permit variation application which proposes the removal

of the leachate extraction limit.
