## 4. Details of our assessment

### **WARNING**

During the August OSM inspection it transpired the CSO discharges via a reedbed to the same location as the STW, which is not reflected in the permit. You were advised of this permit breach and informed a variation is required. No application has been received.

On 13th February 2025 the site was revisited.

No discharge pipe could be located at the permitted point, concluding the issue had not been resolved - which is a breach of Condition:

*2.2 The site; 2.2.1 The discharge activity shall take place at the discharge point marked on the site plan at schedule 7 to this permit, and as listed in table S3.2.*

No other parts of the permit were inspected.
