Waste Regulation Officer Gareth Morris accompanied by Senior Waste Regulation Officer; Craig Coleman and Carriers and Brookers Officer; Andrew Prestt visited the Edwards End of Life Vehicles site (ELV) Unit 9, Newton Industrial Estate, Llantwit Fardre, Pontypridd, Rhondda Cynon Taf, CF38 2EE on 13/02/2025 to conduct a routine site inspection and to assess compliance with environmental permit; AP3395FF

The operator holds a bespoke environmental permit (A13)

The site holds a permit to operate as an End-of-Life Vehicle site (ELV)

Weather on day of inspection, was clear, dry with little wind.

Report Findings

On arrival at the permitted site, it was apparent that there has been no activity on the permitted site recently and that the site is currently non-operational.

Due to the site being no operational there are no permit conditions to assess against and therefore no permit actions or breaches to be recorded.
