### 4. Details of our assessment

This Compliance Assessment Report (CAR) has been issued in response to the submission of the 2024 annual monitoring returns by RWE Generation UK plc (the operator) for activities at Pembroke Power Station, West Pennar, Pembroke, Pembrokeshire, SA71 5SS under permit EPR-DP3333TA.

This CAR was undertaken on 14 February 2025. However, to ensure that the CCS score is attributed to the correct financial year (for billing) the date on CARS has been altered to 31 December 2024.

#### **Annual Returns 2024**

Permit condition 4.2.2 requires the operator:

- 4.2.2 A report or reports on the performance of the activities over the previous year shall be submitted to Natural Resources Wales by 31 March (or other date agreed in writing by Natural Resources Wales) each year. The report(s) shall include as a minimum:
- (a) a review of the results of the monitoring and assessment carried out in accordance with the permit including an interpretive review of that data; and
  - (b) the annual production /treatment data set out in schedule 4 table S4.2; and
  - (c) the performance parameters set out in schedule 4 table S4.3 using the forms specified in table S4.4 of that schedule.
  - (d) where condition 2.3.5 applies the hours of operation in any year shall be reported to Natural Resources Wales.

It is noted that the Annual Service Test Reports on Continuous Emission Monitoring Systems (CEMs) calibration for 2024 have been submitted for information and are not a permit requirement.

Emission releases to air have been correctly reported for LCP1 LCP2, LCP3, LCP4, and LCP5. The

emissions data submitted for Nitrous Oxide (NO<sub>x</sub>) and Carbon Monoxide (CO) are compliant with the permitted parameters.

The Annual Environmental Performance Report 2024 has been correctly produced in-line with condition 4.2.2 of the permit.

- The annual monitoring return submissions were sent within the 2024 reporting period, which is **compliant** with permit condition 4.2.2.
- The monitoring return submissions for Q1, Q2, Q3, and Q4 in 2024 were made inside the respective reporting windows, which is **compliant** with permit condition 4.2.3.
- The monitoring returns submitted include reporting of monitoring carried out in respect of the parameters and emission points specified in table S4.1, S4.2, and S4.3 of schedule 4, which is **compliant** with the environmental permit.
- The monitoring returns submitted are for the reporting periods specified in table S4.1 of schedule 4, which is **compliant** with the environmental permit.
- The monitoring returns have been submitted using the forms specified in table S4.4 of schedule 4 - namely, (i) Air and Energy, (ii) LCP, (iii) Air, (iv) CEMs, and (v) Water, which is **compliant** with the environmental permit.
- The monitoring returns submitted include results and assessments as required by the forms specified in table S4.4 of schedule 4, which is **compliant** with the environmental permit.

Based on the reports submitted by the operator, all emissions at the monitoring points and permitted requirements appear compliant with the specified limits over the 2024 reporting period.
