4. Details of our assessment

I attended site on the 23d January 2025 on a routine OSM inspection. The weather was cold and showery. I was met by the Site Operator, Senior Operator for the area and Process Scientist – thank you for your time during the inspection. We started at the inlet and progressed through the treatment process for the site. There was no indication of excessive carryover in the primary settlement but it

did appear to have been affected by the recent heavy rainfall. The flow on the filterbed appeared to be well distributed. The sludge holding tank was showing signs of deterioration and could pose a risk should it fail, I recommend this is inspected to mitigate the risk of failure. There are flow conditions for this site but no requirement for monitoring. Similarly there is a condition for provision of a sampling point however the site operates a descriptive permit. The outfall showed no signs of sewage fungus despite being set back slightly from the main flow.
