4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised in relation to the annual monitoring and reporting requirements of the permit.

The 2024 air emissions report has not been submitted as per permit condition 4.2.1, Table 4.2 which specifies the deadline date as 31st January 2025.

An update from the site was received on 10th February 2025 to notify NRW that the emissions monitoring had been booked for w/c 17/02/25 and the report would be submitted as soon as possible.

Permit condition 3.5.1 states that the operator will undertake the monitoring in Table 3.1. This has not been completed and a score has been applied;

Score (IR3E) Permit Condition 3.5.1, Table 3.1. C3

When the above report has been submitted this will be treated as data for 2024 and a separate round of air monitoring will need to be arranged for later in 2025.

Action

Implement a system to ensure air emissions monitoring is planned and booked well in advance to ensure compliance with permit condition 3.5.1. for 2025.
