## 4. Details of our assessment

I attended site on an un-announced routine inspection. The weather was cold but dry with no recent rainfall. On site I spoke to the site manager, before heading out with the site compliance manager - thank you for your time during the inspection.

The lagoons nearest reception were the main point of settlement with two linked turbidity monitors and the flocculant dosing all being automated. The storm overflow was a physical weir setting when the pumps were at capacity. The second set of lagoons, adjacent to the conveyors have the same setup. The old settlement pond is no longer in use, however it still operates as an emergency/heavy rainfall additional settlement area.

The flows then enter another series of settlement chambers with oil absorbent booms, to provide additional settlement, before discharging via the sample point. All flow pathways on site are captured by a recently updated series of cross-drains and directed to the settlement lagoons, there are no other discharge points.

We discussed on site the relevant areas of the quarry and ownership, and it appears the permit is still held by Hanson Quarry Products. If this is no longer correct (as the site was rebranded for Heidelberg Materials) then the permit will need updating.

**ACTION:** Confirm if permit holder details are correct and update accordingly.
