4. Details of our assessment

I attended site on an un-announced routine inspection. The weather was cold but dry with no recent rainfall. On site I spoke to the site manager, before heading out with the site compliance manager - thank you for your time during the inspection.

This permit was discussed and the understanding was that the area known as The Manor Quarry was sold to another party within the last few years. This means the water discharge element of this permit is no longer relevant to Builth Quarry or Heidelberg Materials. If the Standard Rules SR2009 No8 "The Management of inert wastes and unpolluted soil resulting from the prospecting, extraction, treatment and storage of mineral resources and the working of quarries, at mines and quarries to an existing standalone water discharge." is still in use by the quarry then I suggest the permit is varied to remove the Manor Quarry discharge elements. If neither parts are now relevant, the permit can either be revoked in its entirety or passed across to the new owners of the Manor Quarry.
