4. Details of our assessment

This Compliance Assessment Report (CAR) has been issued in response to the 2024 annual monitoring return submissions (1 January - 31 December) by Mekatek Limited (the operator) for activities at Amex Park, Llansteffan Road, Johnstown, Carmarthen SA31 3NF under permit EPR-YP3937SH.

This CAR was undertaken on 17 February 2025. However, to ensure that the CCS score is attributed to the correct financial year (for billing) the date on CARs has been altered to 31 December 2024.

Annual Monitoring Returns 2024

Permit condition 4.2.2 states:

- 4.2.2 For the following activities referenced in schedule 1, table S1.1 (A1 to A4) a report or reports on the performance of the activities over the previous year shall be submitted to Natural Resources Wales by 31 January (or other date agreed in writing by Natural Resources Wales) each year. The report(s) shall include as a minimum:
- (a) a review of the results of the monitoring and assessment carried out in accordance with the permit including an interpretive review of that data;
 - (b) the annual production /treatment data set out in schedule 4 table S4.2; and
 - (c) the performance parameters set out in schedule 4 table S4.3 using the forms specified in table S4.4 of that schedule.

Compliance comments

The operator has highlighted the instances of nitrogen exceedance to W1 during the compliance year, which NRW were notified of at the time. This was an issue that was occurring in the previous compliance year (2023/24), however measures were implemented with the inclusion of de-nitrifying bacteria in the biological treatment stage of the ETP; this seemed to successfully reduce levels. Further work is being conducted to ensure this parameter is kept compliantly within the permitted ELV going forward.

- The monitoring returns submitted include reporting of monitoring carried out in respect of the parameters and emission points specified in table S4.2 of schedule 4, which is **compliant** with the environmental permit.

- The monitoring returns submitted are for the reporting periods specified in table S4.2 of schedule 4, which is **compliant** with the environmental permit.
- The monitoring returns have been submitted using the forms specified in table S4.4 of schedule 4, which is **compliant** with the environmental permit.
- The monitoring returns submitted include results and assessments as required by the forms specified in table S4.3 and S4.4 of schedule 4, which is **compliant** with the environmental permit.

Based on the reports submitted by the operator, all emissions at the monitoring points for performance parameters appear compliant with the specified emission limits.
